ROLLINSFORD SCHOOL DISTRICT WARRANT 2009 THE STATE OF NEW HAMPSHIRE

To the inhabitants of the School District of the Town of Rollinsford qualified to vote in district affairs. You are hereby notified to meet at the Rollinsford Grade School in the said district on the seventh day of March 2009, at 9:00 o'clock in the morning, to act upon the following subjects:

- 1. To determine and appoint the salaries of the School Board (Chair \$1,200, two (2) members at \$1000 each), Truant Officer (\$40), Moderator (\$50), District Clerk (\$50), Treasurer (\$650), Supervisor(s) of the Checklist (three (3) at \$15 each) for a total of \$4,035.
- 2. To hear the reports of Agents, Auditors, Committees or Officers chosen and pass any vote relating thereto.
- 3. To choose Agents, Auditors and Committees in relation to any subject embraced in this warrant.
- 4. To see if the School District shall accept the provisions of RSA 198:20-b providing that any School District at an annual meeting may adopt an article authorizing indefinitely, until specific rescission of such authority, the school board to apply for, accept and expend, without further action by the school district, unanticipated money from a state, federal or other governmental unit or a private source which becomes available during the fiscal year.

Passage requires a majority vote and will stay in effect until rescinded at an annual meeting.

- 5. To see if the school district will raise and appropriate the sum of four million, six hundred fifty-one thousand, five hundred thirteen dollars (\$4,651,513.00) for the support of schools, for the payment of salaries for the school district officials and agents, and for the payment of statutory obligations of the district, and to authorize the application against said appropriation of such sums as are estimated to be received to the district; the school board to certify to the selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by the taxes in the town.
- 6. To see if the School District will vote to raise and appropriate the sum of up to (twenty-five thousand dollars) \$25,000 to be used for studies related to land acquisition with such amount to be funded from the June 30th undesignated fund balance for transfer July 1st. This will be a non-lapsing appropriation per RSA 32:7 and will not lapse until the land acquisition studies have been completed or by June 30, 2011 whichever is earlier.

(Not Recommended by the Rollinsford Budget Committee) (Recommended by the Rollinsford School Board)

7. To see if the school district will raise and appropriate the sum of up to (ten thousand dollars) \$10,000 to be placed in the Capital reserve fund for the purpose of education of educationally disabled children with such amount to be funded from the June 30th undesignated fund balance for transfer on July 1st.

(Not Recommended by the Rollinsford Budget Committee) (Recommended by the Rollinsford School Board)

8. By Petition: To see if the District will vote to establish an AREA School Plan Review Board in accordance with New Hampshire RSA 195-A:14 for the purpose of reviewing the existing AREA School Plan between Somersworth and Rollinsford; and/or to undertake a study of the feasibility and suitability of withdrawal from the AREA School.

- 9. By Petition: To see if the District will vote to direct the School Board to begin discussions with other school districts on tuition alternatives for Rollinsford's school children.
- 10. By Petition: To see if the District will vote to establish a committee of Rollinsford residents that will work with and report to the School Board and/or the AREA School Plan Review Board for the purpose of compiling the data necessary to make informed decisions regarding the options for educating Rollinsford's school children.
- 11. By Petition: To see if the School District shall adopt the provision of RSA 40:13 (known as SB2) to allow official ballot voting on all issues before the Rollinsford School District on the second Tuesday of March. (3/5 majority required) (Discussion only).
- 12. To transact any other business that may legally come before this meeting.
